- Conservator or Power of Attorney services for elderly population with income/assets beyond SSI/SSDI. No guardianship or caregiving services. Does not accept individuals on Medicaid.
- Free 1 hour initial consultation. Services after that \$105 per hour POA, \$115 for conservatorship.
- Assists with financial needs relating to conservator or POA, not medical.

- Court appointed conservator/guardian. Medical &/or financial power of attorney. Must have income other than Social Security to pay for services.
- Services with care coordinator - \$45 per hour, legal guardian - \$125 per hour.

Colorado Elder Care Solutions

Definition of Terms

Representative Payee: A person or organization to receive benefits on behalf of someone who cannot manage his/her money because of their youth, mental, or physical impairment.

Conservator: Handles money, paying bills, and business matters for people that have assets more than social security income. Usually own a home, earn more than \$10,000.

Guardian: Have full control over medical and other decision-making processes. Can usually act as payee if individual makes less than \$10,000 (eg. SSI/SSDI only).

Professional Fiduciary Services: Include guardianship, conservator, trust, & power of attorney services.

- Provide care management, and guardianship for clients who are elderly or disabled; in home care companion, and CNA
- In both cases, an initial assessment is needed to know how individual is doing and to develop a care plan. Initial assessment for home care at no charge and on-going care management assessment is \$125 per hour.
- Guardianship services, 1 time set up fee \$350 and then ongoing guardianship services \$125 per hour, follow up for details on billing and fees.
- Personal care worker \$22 per hour, CNA \$24 per hour.

- Provide some power of attorney and other fiduciary services. Limited guardianship services at \$125 per hour at 6 minute increments. Representative payee at \$60 per hour at 6 minute increments, Care management at \$120 per hour at 6 minute increments.
- Representative payee services only offered in conjunction with care management or guardianship services.
- Services: Geriatric and adult care management, professional senior and disability assessment, short-term counseling and/or consultations for elder care planning, advanced planning services for seniors, elderly, and disabled adults, long-distance caregiving, financial management/insurance claims, guardianship and fiduciary roles .
