Child and Youth Mental Health Treatment Act (CYMTHA)

This act allows families to access mental health treatment services for their child or youth. This is an alternative to child welfare involvement when a dependency and neglect action isn't warranted.

Eligibility:

- Must have a mental health diagnosis
- Must be at risk of out of home placement
- Isn't eligible for Medicaid
- Accesses the program prior to their 18th birthday
- Doesn't have a pending or current dependency and neglect action with child welfare.

Things to Consider:

- Parents or the legal guardian are responsible for 7% of the total costs of treatment provided under the act and must pay a minimum of \$50 per calendar month.
- If a child or youth is placed in residential care under this funding, the parent or legal guardian must apply for SSI for the child or youth within 10 business days.

Psychiatric Residential Treatment Facilities

A Psychiatric Residential Treatment Facility (PRTF) is an inpatient psychiatric facility for children and youth who need intensive psychiatric care but do not require the level of care of an inpatient hospital setting. PRTF services are for Health First Colorado (Colorado's Medicaid Program) members under the age of 21 who need inpatient services to treat a psychiatric condition under the direction of a physician. If the client was receiving services just prior to turning 21, the client may receive services before reaching the age of 22.

- Short Term Respite Care
 - o Treats children 7 − 18 years of age
 - A short-term service designed to assist Colorado families in preventing the disruption of placement for youth who may be at risk of being removed from their families or who are already placed in foster care
- Day Treatment
 - Treats children 7 18 years of age
 - Designed for youth facing challenges in the public school system, the legal system, or transitioning to a less restrictive environment
