- Student loans may be forgiven in the following circumstances, applies to Federal student loans only, not private loans
- Call or go online to apply
 - You are a veteran who has been determined by the VA to be unemployable due to a service connected disability, and you provide documentation from the VA of that determination
 - You have received an SSA notice of award for SSDI or SSI stating that your next scheduled disability review will be 5-7 years or more from the date of your last SSA disability determination, and you provide a copy of that SSA notice of award
 - You provide a certification rom a physician in Section 4 of this discharge application that you are unable to engage in any substantial gainful activity by reason of a medical determinable physical or mental impairment that:
 - Can be expected to result in death
 - Has lasted for a continuous period of not less than 60 months
 - Can be expected to last for a continuous period of not less than 60 months
