- Non-profit agency to assist people who have been impacted by criminal acts or non-crime related traumatic events such as suicide, fatal car accident, or natural disaster. Services are also provided to secondary victims (family members or witnesses who were impacted by the trauma).
  - Serves the following areas: Arvada, Golden, Edgewater, Lakeside, Mountain View, Morrison, Wheat Ridge, and Colorado School of Mines, and victims with no local advocate who are referred to VOI.
  - Services included: 24-Hour Crisis Hotline, 24-hour on-scene response at request of law enforcement, crisis intervention, risk assessment, informing victims of their rights, legal process support, crisis counseling and emotional support, referrals and resources, helping to prevent revictimization, and victim subsidy program.

  - Emergency shelter services are for women only and children up to age 18. Shelter services are provided in both English and Spanish, and necessities are provided by the shelter program,
  - including bedding, food, personal hygiene items, and basic medical care. The length of stay in the shelter is 30 days and extensions may be granted.

## Phone Apps

### **Aspire News App: <https://www.whengeorgiasmiled.org/aspire-news-app/>**

- Looks like any other iPhone or Android news app, but it is a potentially lifesaving domestic violence alert system. It is disguised as a normal icon and even has a decoy home page, so you'll be safe if your abuser takes your phone.
- When you go to the "Help" section of the page, it provides a list of local domestic violence resources.
- The App does not serve as a replacement for emergency services – in any situation where you feel that you may be at risk, please dial 911 or your local emergency number.

### **My Plan App: <https://myplanapp.org/>**

- myPlan is a free app offered in English and Spanish to help with safety decisions if you, or someone you care about, may be experiencing abuse in an intimate relationship. It's private, secure, personalized, & backed by research with domestic violence survivors involved every step of the way.
  - Completely anonymous to use - no account set up required
  - Set your own secure PIN code to keep info private
  - "Dummy code" hides contents of the app if forced to log in
  - Changeable icon to hide the app on your home screen

## **ICE BlackBox**

- a mobile app that turns your smartphone into a secure recording device for emergencies, capturing video, audio, and GPS data that's uploaded to the cloud to prevent forced deletion, partnering with groups like the [National Sheriffs' Association](#) (NSA) for crime reporting. It acts as a personal safety tool, letting users record evidence and share it, with features to alert contacts and law enforcement, deterring criminals by making them accountable.
