- Serves survivors of domestic violence, stalking, and sexual assault.
- Assists with understanding the protection order process and completing paperwork.
- Protection orders can be obtained between 8:30AM and 4:30 PM, Monday-Friday.
  - Walk-ins only, no appointment needed.
  - Virtual hearings and accompaniment to permanent protection order hearings available.
- Legal Clinic is held twice per month on the first and third Wednesday.
  - Volunteer attorneys and/or paralegals provide advice, information, and assistance with family law cases.
  - Call 720-856-2344 for eligibility requirements and to register.
  - One monthly clinic is held for Spanish-speaking survivors.
