- Enforces the Boulder Human Rights Ordinance which protects individuals against discrimination in employment on the bases of ancestry, color, creed, gender variance, genetic characteristics, marital status, mental disability, national origin, physical disability, race, religion, sex, sexual orientation, age, parenthood, pregnancy, and custody of a minor child.
- Offers mediation when a discrimination complaint is filed.

- Appointments required for in-person services.
- Party must file within 6 months of alleged employment discrimination.
