- Designated Beneficiary Agreements allows two unmarried people to affirm in writing that they
 want each other to have legal rights, benefits, and protections to make certain decisions about
 each other's health care and estate administration as well as treatment in medical emergencies,
 during incapacity, and at death.
- Designated Beneficiary agreements will be superseded by other legal documents (e.g. will, trust, etc.).
- Must be properly recorded at the County Clerk and Recorder's office.
