- Provides the following assistance to Colorado residents:
 - Eyeglasses
 - Prescriptions
 - Medical Equipment and more
- Friends of Man accepts applications ONLY from a referring professional on behalf of the applicant. This can be a social worker, nurse, school counselor, teacher, principal, social worker, clergy, health care technician, etc.
 - Applications CANNOT be submitted by the applicant, the vendor, or by a relative or friend.
 - Applicants must be a U.S. citizen, and a resident of Colorado for at least one year
 - The applicant's total household income must not be greater than 300% of the Federal Poverty Guidelines.
 - Photo ID
 - Vendor Estimate
 - Physician Documentation (if requesting for disability or illness)
- How to Apply
 - Submit application (filled out and signed) either by email to applications@friendsofman.org or by U.S. mail to P.O. Box 937, Littleton CO 80161-0937
 - Screeners will contact you with any additional questions or requests for further documentation.

New Eyes for the Needy

- New Eyes assists individuals in the United States who have no other resources with which to obtain a basic pair of eyeglasses. Approved applicants have no out-of-pocket costs in receiving their New Eyes glasses.
- New Eyes provides a basic pair of single or lined bifocal lenses at no cost to the client. Special requests including upgrades such as tinted, progressive or Transition lenses are available for a discounted out-of-pocket fee
- Social service agencies/health advocates can apply on a client's behalf.
- To be eligible for our program, applicants must:
 - Be in financial need - reside in a household with net monthly income below 250% of US Poverty Guidelines.
 - Have had a recent eye exam (within the last 24 months) with a pupillary distance measurement. New Eyes does not pay for eye exams.
 - Have no resources to pay for glasses every year or as needed, including federal or state programs.

- A public service program of the Foundation of the American Academy of Ophthalmology (AAO). Provides medical eye care at no out-of-pocket cost to those who qualify
- Those who are age 18 or older and who have not seen an EyeMD in three or more years may be eligible to receive a medical eye exam and up to one year of care at no out-of-pocket cost for any disease diagnosed during the initial exam
- Those who are determined to be at increased risk for glaucoma (by age, race, and family history) and have not had an eye exam in 12 months or more may be eligible to receive a free glaucoma eye exam if they are uninsured.
- This program does NOT provide eyeglass prescriptions or cover the cost of glasses.

Online Resources for Glasses

For most online resources, you will need a current prescription and will need to know your Pupillary Distance (PD). PD is the distance (in mm) between your pupils. This is important because each lens has an optical center that needs to be placed directly over your pupil. You can get this measurement from your eye doctor during your exam, or you can measure it on your own (see websites below for information on how to measure).
