# **Federal Lifeline Program**

### **Program Information:**

• If eligible, this program provides eligible low-income individuals with **free**: cell phone, monthly data, unlimited texting, unlimited monthly minutes.

#### **Eligibility**:

- Income must be at or below 135% of federal poverty guideline, or participate in any of the following:
  - Medicaid
  - Supplemental Nutrition Assistance Program (SNAP)
  - Federal Public Housing Assistance
  - Supplemental Security Income (SSI)
  - Tribal Programs
    - Tribally Administered Temporary Assistance for Needy Families (TTANF)
    - Food Distribution Programs on Indian Reservations (FDPIR)
    - Bureau of Indian Affairs General Assistance

## **Program Rules:**

- Only one Lifeline discount may be received per household. Discount may be received on landline or wireless service, but not both.
- Annual recertifications for the service are required.
- If your Lifeline service is free, you must use it at least once every 30 days to maintain your service. If you don't, you will get a 15-day notice to use it or it will get turned off.

#### To Apply:

Option 1: Complete a Lifeline Program application. Once you're approved, you will receive an application ID that you will add to your application with the phone carrier that you wish to use to apply for a phone through the Lifeline program (see *last bullet point below*)

- Project 10Million's Direct to Parent/Guardian program provides internet access to eligible families Program Benefits:
  - Approved families receive 200GB of mobile data per year for 5 years and a FREE mobile hotspot
  - Access to low-cost laptops and tablets.

### Eligibility:

- New and existing T-Mobile (including Metro by T-Mobile and Assurance and Sprint) as well as Non-T-Mobile customers are eligible to apply.
- Families with a child enrolled in any one of the following programs:
  - Supplemental Nutrition Assistance Program (SNAP) via P-EBT or EBT
  - Temporary Assistance for Needy Families (TANF)
  - Food Distribution Program on Indian Reservations (FDPIR)
  - Community Eligibility Provision (CEP)
  - Medicaid
  - Head Start
  - o Foster youth, migrant, homeless, or runaway youth
- Available to residents of the United States and Puerto Rico. Not currently available in the US Virgin Islands.
