#### What you need to know about rent assistance:

- Many, but not all, assistance programs require an eviction notice from your landlord
- Funds tend to be intermittent; it is a good idea to call as many places as you can
- TANF recipients can call their TANF caseworker at 303-271-4748
- Section 8 recipients can contact their coordinator for additional resources
- Call 211 from any phone for additional referrals

### **State Rental Assistance**

#### **CARE Center Daily Random Selection**

Call daily (Monday - Friday) between 8:30am - 5:30pm at 303-838-1200

- Must be a resident of Colorado with a current court summons
- CARE Center will conduct a random selection process each day- and selected applications can apply for Emergency Rental Assistance.

## **Emergency Rental Assistance Program (ERAP) / Colorado Emergency Rental Assistance (CERA)**

Must check online when pre-application windows are open. Opening 1x per month currently.

- Must meet income guidelines (60% AMI)
- Fallen behind on rent and are at risk of eviction
  - Those facing eviction/current court proceedings will be prioritized- but not required to apply
- Have not received any financial assistance towards rent from a local, state, or federal funding source within the last 24 months.

- Adams County: The application for emergency rental, mortgage or utility assistance is available on the 1st of each month between 9am-11am.
- Weld County: The application for emergency rental and mortgage assistance will be available on the 1st of each month and remain open until monthly capacity is reached.
- Eligibility:
  - o 1-3 months past due, including current month
  - No more than \$5000 past due, including the current month
  - Must reside in Adams or Southern Weld
  - Assistance is limited to one time in a 12-year period
  - Verification will be required before selection

- Senior Tenant-Based Rental Assistance Program
  - Two-year program that provides rental assistance and supportive case management for lowincome Broomfield seniors

- Limited assistance is provided to qualified homeowner(s) who have experienced a temporary disruption in income, unforeseen expenses or other hardship which caused, or is anticipated to cause, the homeowner to fall behind on their mortgage, Home Owners Association, or real estate tax payments.
- Homeowner must attend a counseling session with a HUD approved Housing Counseling agency to determine program eligibility. The homeowner must demonstrate the ability to resume payments after assistance has been provided.
