These resources are primarily for teens and pregnant youth.

An **emergency shelter** offers immediate shelter for one night or longer.

A **transitional housing program** generally offers housing for longer durations. There are generally wait lists to get into transitional housing programs. Most of these programs require residents to complete an application, interview, and pay monthly rent.

- SWSN provides emergency overnight shelter on life-threatening winter nights for the single individuals living on the streets in West Arapahoe and Jefferson counties. Volunteers welcome guests by name and provide a hot meal and a bed roll on severe weather nights from October 1st through April 30th.
- Eligibility requirements: must be 18 or older without children living with you, able to get up and down off the floor without help, must live in Jefferson or west Arapahoe County, must not have pets.
- Anyone who is interested in staying in a shelter site must register with SWSN. Registration Sites help individuals with the screening and registration process for access to the shelter for the season.
 Registration cannot be done over the phone or online. Each guest must visit a partner location in person to register.

Cold/Severe Weather Shelter Referral Hotline (2-1-1)

- 8AM to 5PM Monday through Friday
- After hours, contact local sheriff's department for possible vouchers
- Go in person to one of these agencies during business hours if the weather is predicted to meet conditions listed above to see about availability at a temporary shelter in a neighborhood church.
- If a snowstorm is predicted, shelter can be obtained for up to three nights in a row.
- Men will be separated from women and children.
- Background check will be run, people with violent offenses within the last year are not eligible to stay.

 - Leave message for parents, receive messages, and place conference calls to talk things out.
 - o You can leave a message for the child in your life with us, and when they contact NRS, we will deliver it.
 - When you and the child in your life are ready to talk, we can serve as a neutral mediator on a three-way call.

- Emergency shelter and drop-in center for homeless and runaway youth.
 - Call for shelter availability, best to call earlier in the day.
 - Overnight emergency shelter for youth ages 15-20.
 - Services at the shelter: three meals a day, showers, counseling, case management, vaccinations, HIV and pregnancy testing, health screening, clothing, hygiene products, and resource referrals.
 - Services at Urban Peak's Drop-In Center: showers, a hot breakfast Monday through Friday, lockers, and laundry services.
 - Owns and operates three transitional housing apartment complexes which offer support through individualized case management services.

 - If a resident comes into the program with a job or other income program fees begin upon intake, \$300 a month. You must start to pay program fees within 90 days of intake.

 - Individuals ages 18-24 are eligible to apply, if they have spent at least one day in foster care on or after their 16th birthday.
 - They must be homeless, or in the process of becoming homeless, couch surfing, in a transitional living program, or living in overcrowded or dilapidated housing.

- If you are a resident of Denver and have a pet that you need to surrender
- In Pet Surrender, they offer compassion and understanding to owners who relinquish their pets and a warm welcome to the animals that are being entrusted to their care.
- Call to schedule an appointment.
- What to bring to the shelter:
 - Pet records a copy of vaccination and vet records
 - Behavior information be prepared to discuss your pet's daily habits and behaviors
 - Safe transportation be sure that dogs are on leashes and cats, or other small animals, are in carriers.
 - DDFL will ask for a \$30 donation to be put toward the cost of your pet's care.
 - If you are disabled and/or don't have transportation to take the pet to the shelter, a Denver resident may contact Denver Animal Protection at 720-913-1311 for assistance regarding an owner's surrender pet.
 - o Hours: Monday-Friday, 9:00AM-7:00PM; Weekends: 9:00AM-5:00PM
 - Non-Denver County residents: contact local animal shelter or animal control agency.

- Open daily, from 10 a.m. to 5 p.m. for pet relinquishments
- Pet surrender program for Jefferson County residents.
 - This is not temporary care, and your pet will be placed for adoption. You must provide proof of residence.
 - You will be asked to sign a waiver releasing ownership, asked about your pet's behavior, and your pet will undergo a behavioral test to determine the best course of action for your pet's placement.
 - Will accept any in-county animal regardless of the ability to pay the relinquishment fee.
- Foothills Animal Shelter has partnered with Human Service Agencies and our Animal Control Partners
 to bring services to the citizens of Jefferson County. Simply put, it is the right thing to do to make lives
 better for pets and people.
 - o PorchLight, A Family Justice Center (FJC)
 - FJC provides comprehensive legal, emotional and critical supportive services for survivors of domestic violence, sexual assault, child abuse, abuse of at-risk individuals, elder abuse, and human trafficking. Located in Lakewood, Colorado, the FJC is a safe, caring environment that provides one-stop services and support. Key local government agencies, law enforcement, community, social and legal service providers, and District Attorney's Offices are located on-site at the FJC to make it easier for victims and survivors to get help. We have an office at the center so we can provide care and resources to the animals belonging to clients of the center.
 - Foothills Animal Shelter provides clients with pet food, animal supplies, vaccinations, and spay/neuter services. We will also provide short-term housing when requested.

- Colorado Safe Parking Lot Initiative (CSP)
 - CSPI is grassroots, all-volunteer nonprofit organization working to create a statewide network of safe, legal parking locations for individuals and families sheltering in vehicles because they are experiencing homelessness. Safe overnight parking is available for individuals experiencing homelessness and living in a passenger vehicle in Jefferson
 - County's two lots, located in Golden and Arvada. Safe lot guests have access to bathroom facilities, housing navigation and other services.
 - Foothills Animal Shelter provides clients with pet food, animal supplies, vaccinations, and spay/neuter services. We will also provide short-term housing when requested.
- Protective Custody Program
 - Jefferson County Animal Control and the cities of Lakewood, Arvada, Wheat Ridge, Golden, Edgewater, Sheridan, and Westminster Animal Control Agencies partner with us to provide Protective Custody Services. Our Animal Control Partners pick up and transport animals to Foothills Animal Shelter when the owners have been evicted, hospitalized, died, become homeless, or are experiencing domestic violence and need to flee an unsafe situation.
 - Foothills Animal Shelter provides ten days of boarding services at no charge to the families in crisis.
